- If you have never taken **Noncredit classes or applied to SBCC, Click on “Create an Account”** and follow the instructions below.





Creating Your Account

1. You can use an **email address** or your **phone number** to sign in. You will then receive a code to your email address or phone number that you will enter
2. Enter your **Personal Information** such as your legal first, middle and last name, suffix (if applicable), preferred name, date of birth, and home address
3. **Create a password** for your CCCApply account. Then, select create account
4. **SKIP Verify with ID.me** by clicking Verify later. Then select **yes, I want to opt out of ID.me**. If you want to verify your identity, you can select verify me. You will be redirected to the ID.me sign in page. **This is not a requirement as an SBCC student**

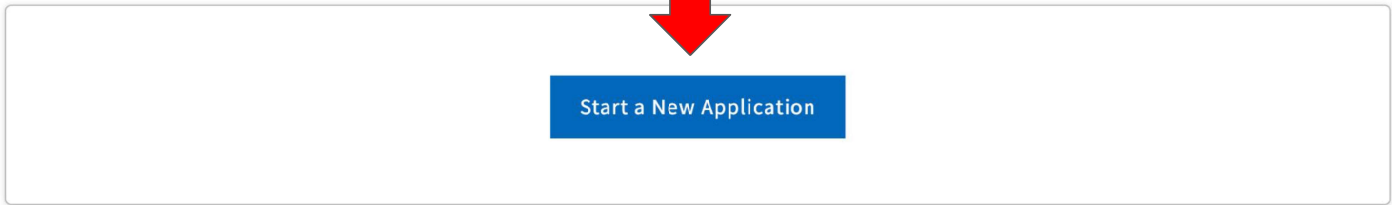

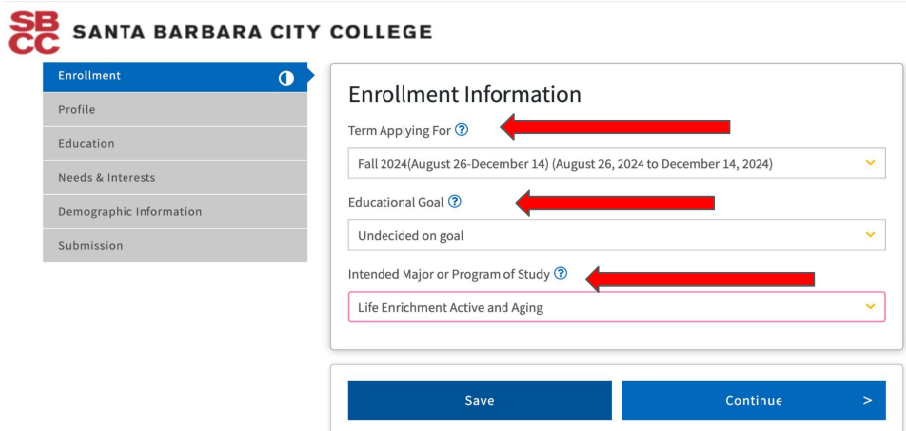
